Code Of Federal Regulations 416.1151.

Disasters. How we treat the repair or replacement of lost, damaged, or stolen resources. U.S. Treasury Dept.: Title VI, Section 504, the Age Discrimination Act, and Title IX Section 504 of the Rehabilitation Act of 1973 (prohibits disability discrimination)

Average: \$600.00 state unemployment plus \$300.00 weekly Federal = \$900.00 per week for 18+ months = \$64,800 plus grants, etc...

On January 31, 2020, The Secretary of Health and Human Services (HHS) declared a public health emergency under section 319 of the Public Health Service Act (42 U.S.C. 247d), in response to COVID–19.

On March 13, 2020, by Proclamation 9994, the President declared a national emergency concerning the coronavirus disease 2019 (COVID-19) pandemic. On May 11, 2023 The Federal COVID-19 PHE declaration ended.

This would be like FEMA dealing out elderly & disabled after a declared disaster.

What is financial abuse in disability?

Financial exploitation occurs when someone improperly uses the money, assets or resources of a person with disabilities or an older adult to the abuser's advantage or to the disadvantage of the person with disabilities or older adult.
